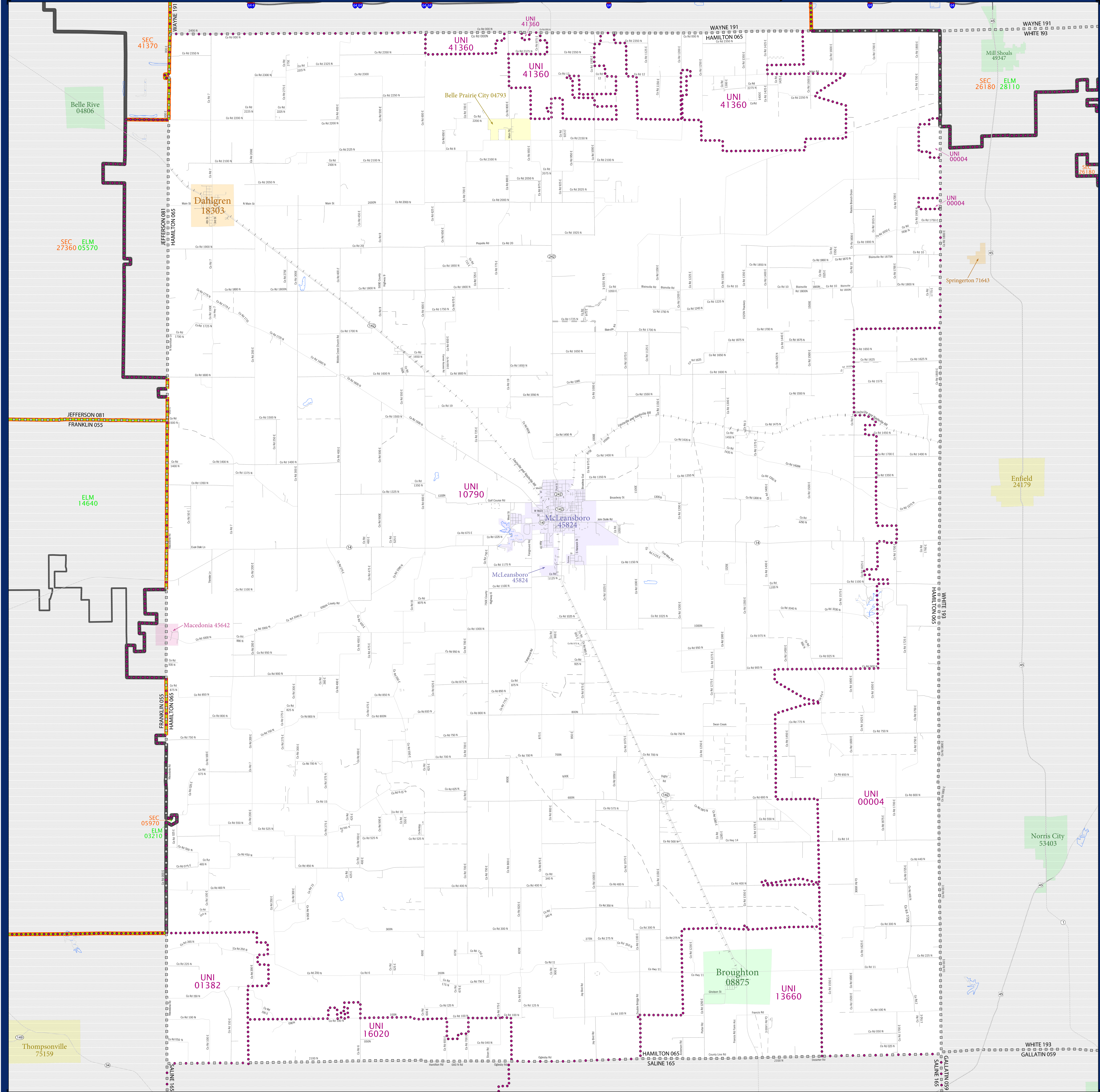


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Hamilton County, IL

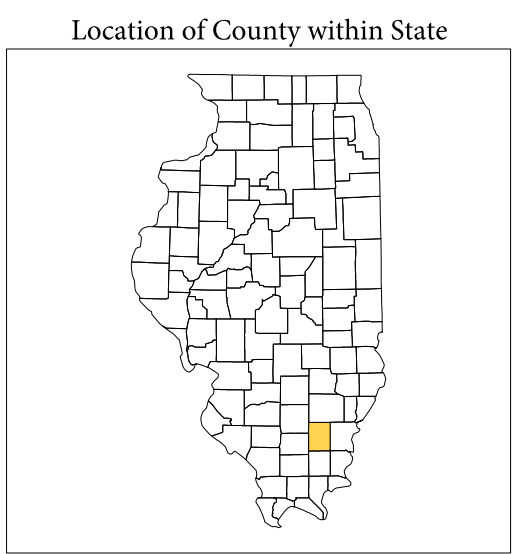
