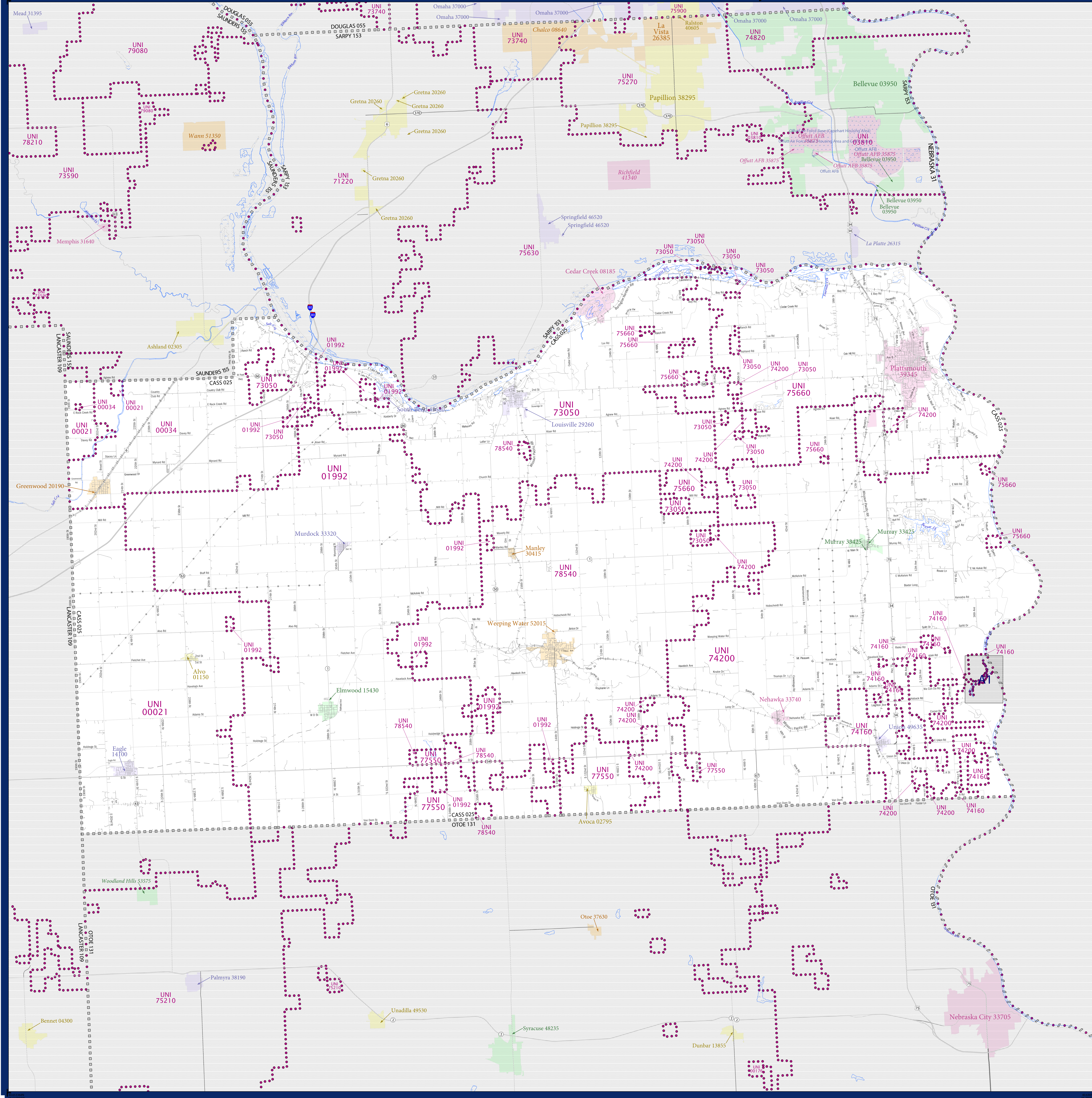


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Cass County, NE

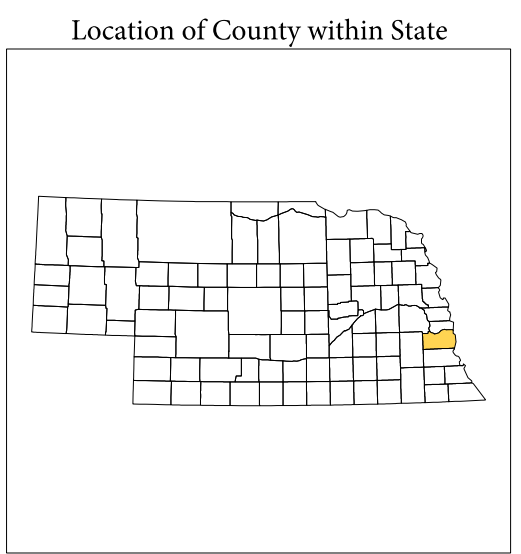
