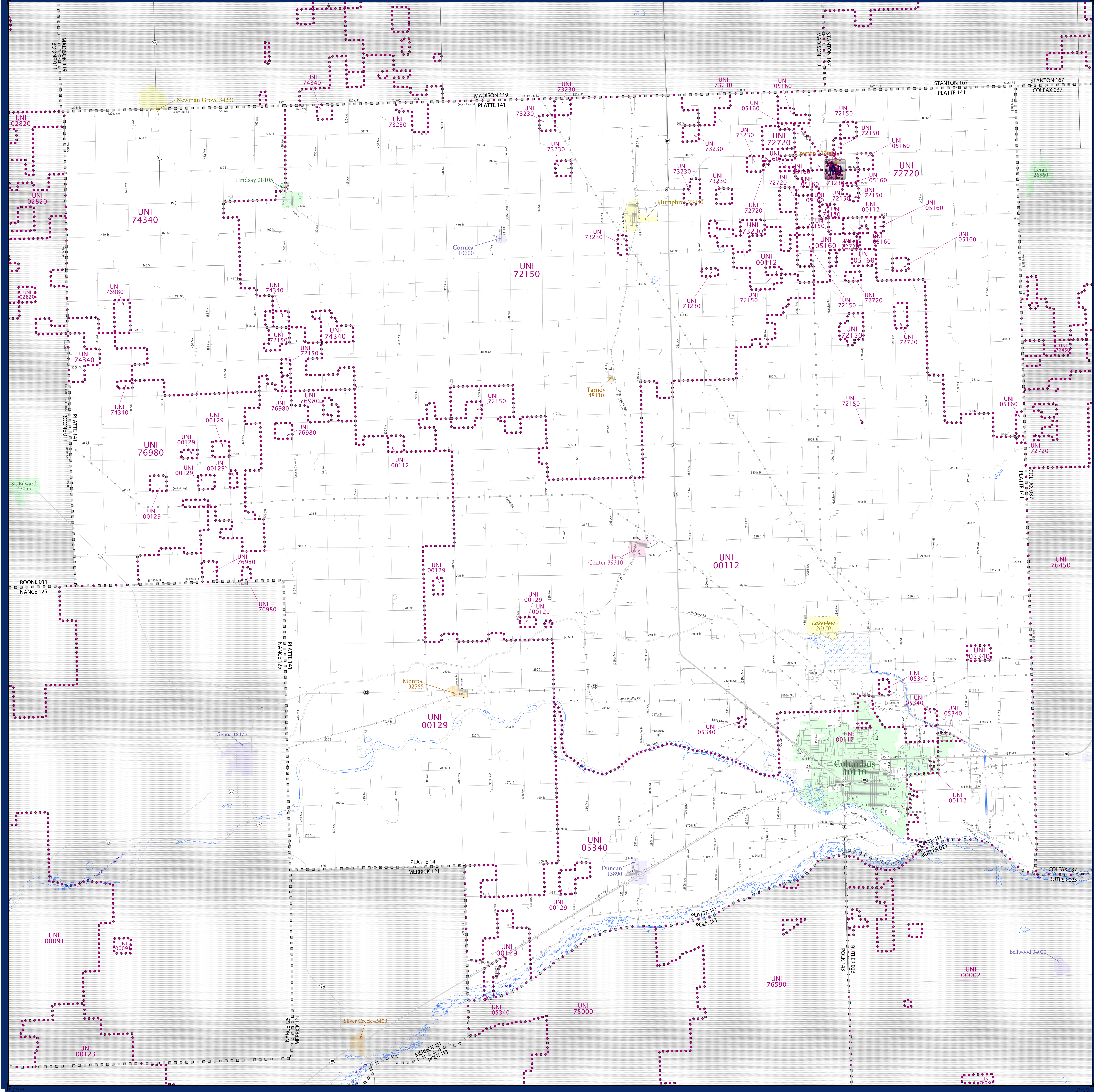


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Platte County, NE

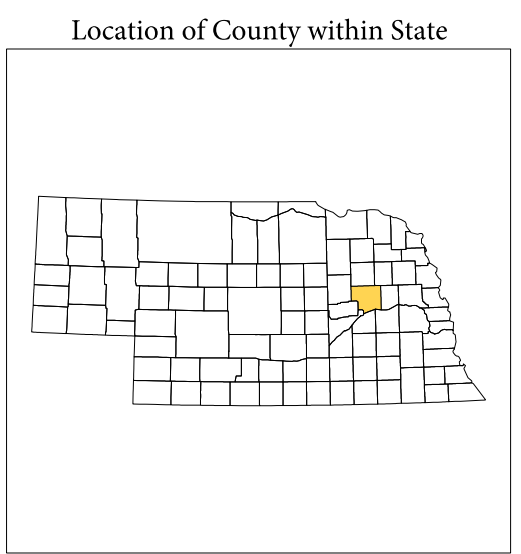
