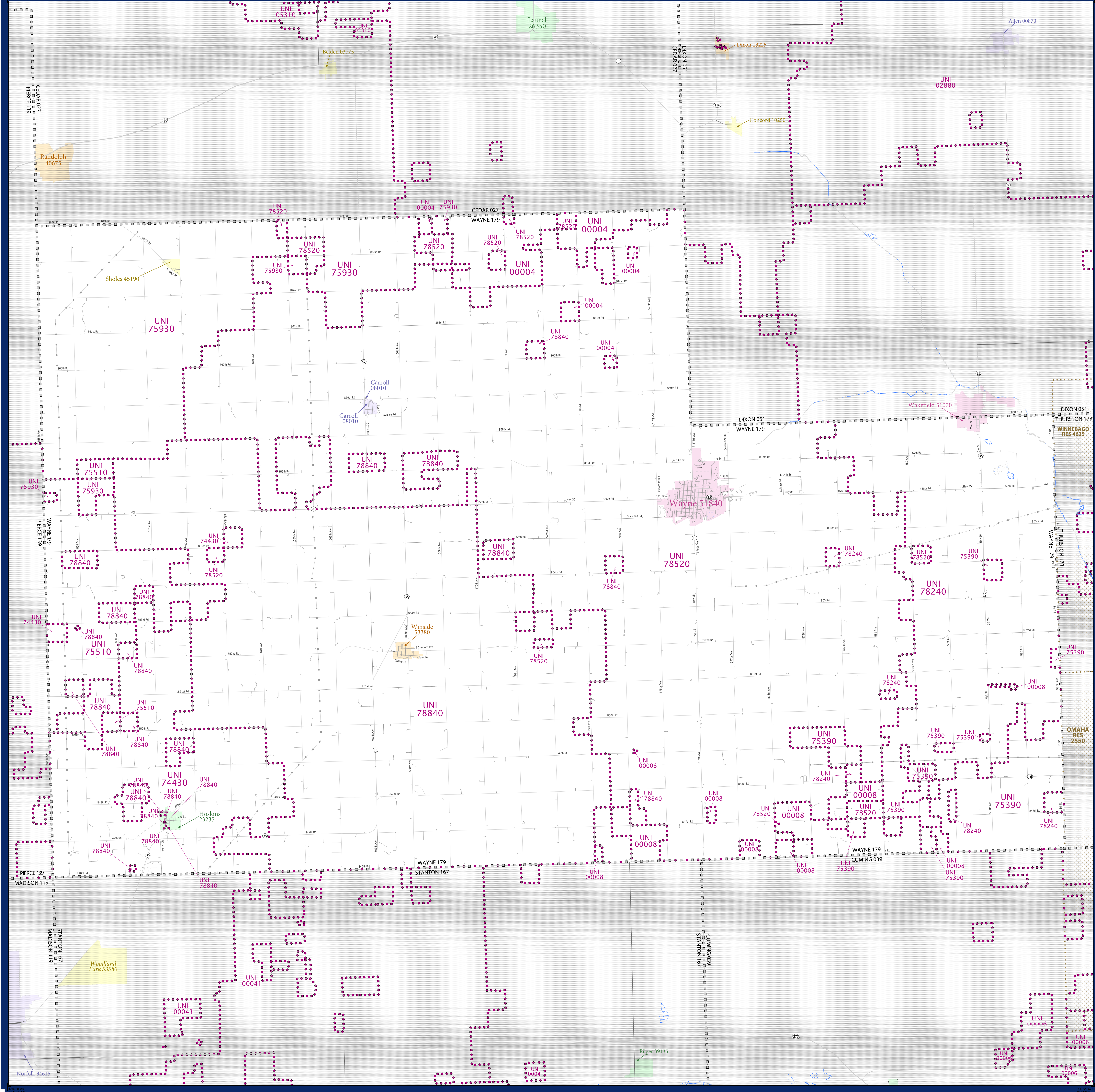


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Wayne County, NE

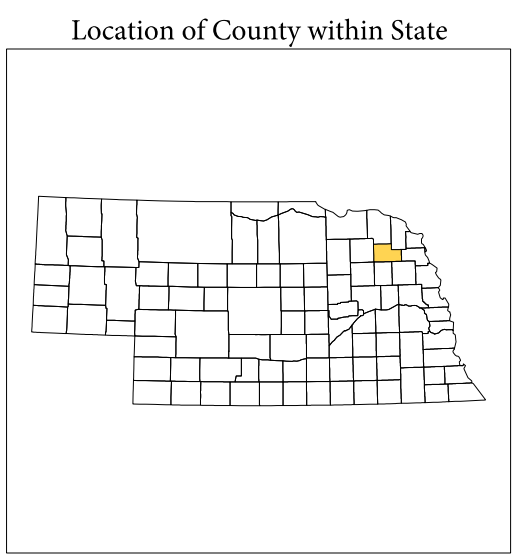
