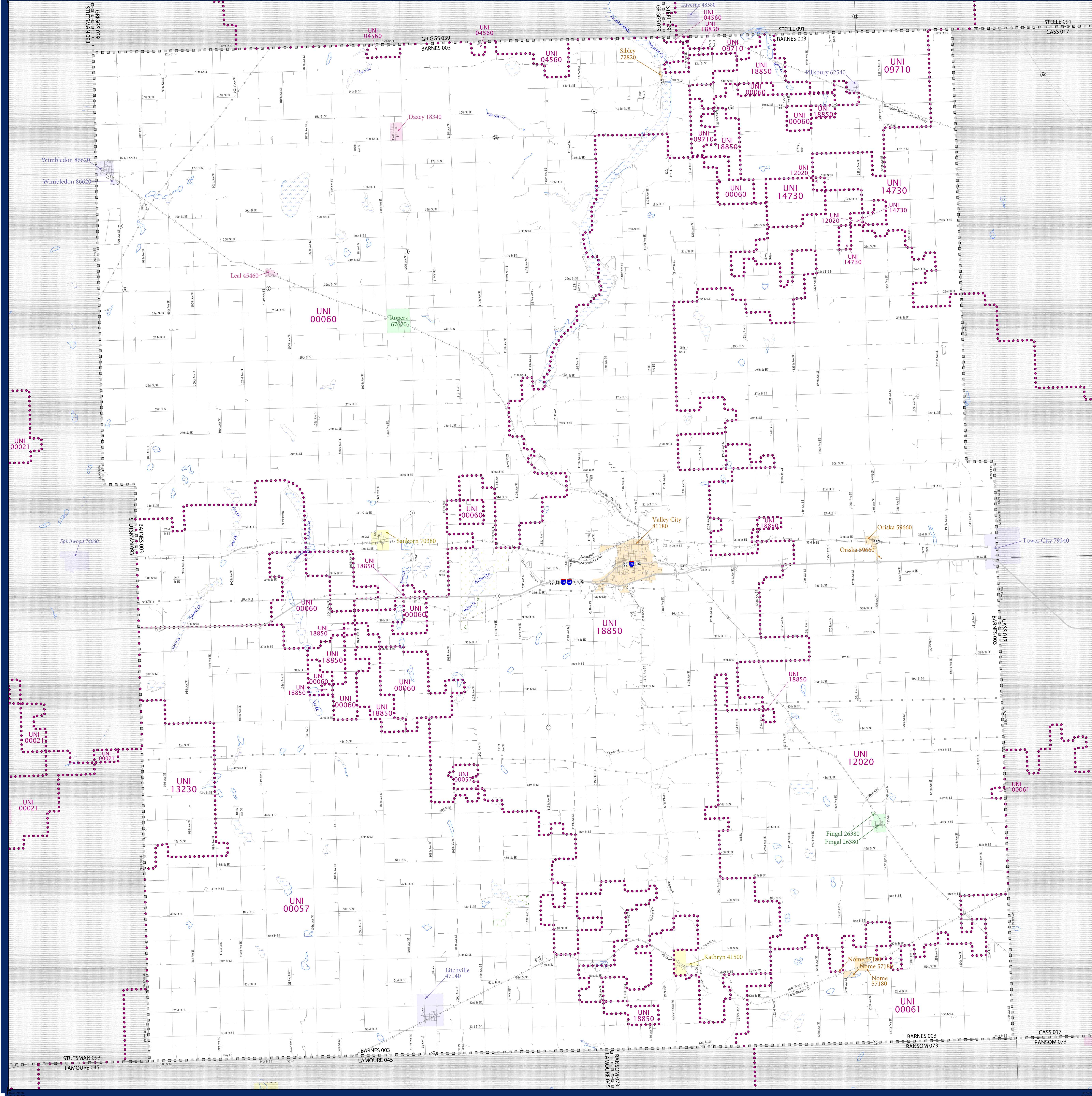


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Barnes County, ND

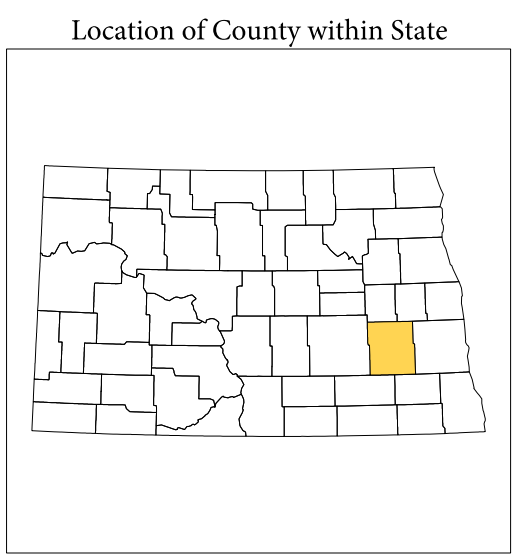
