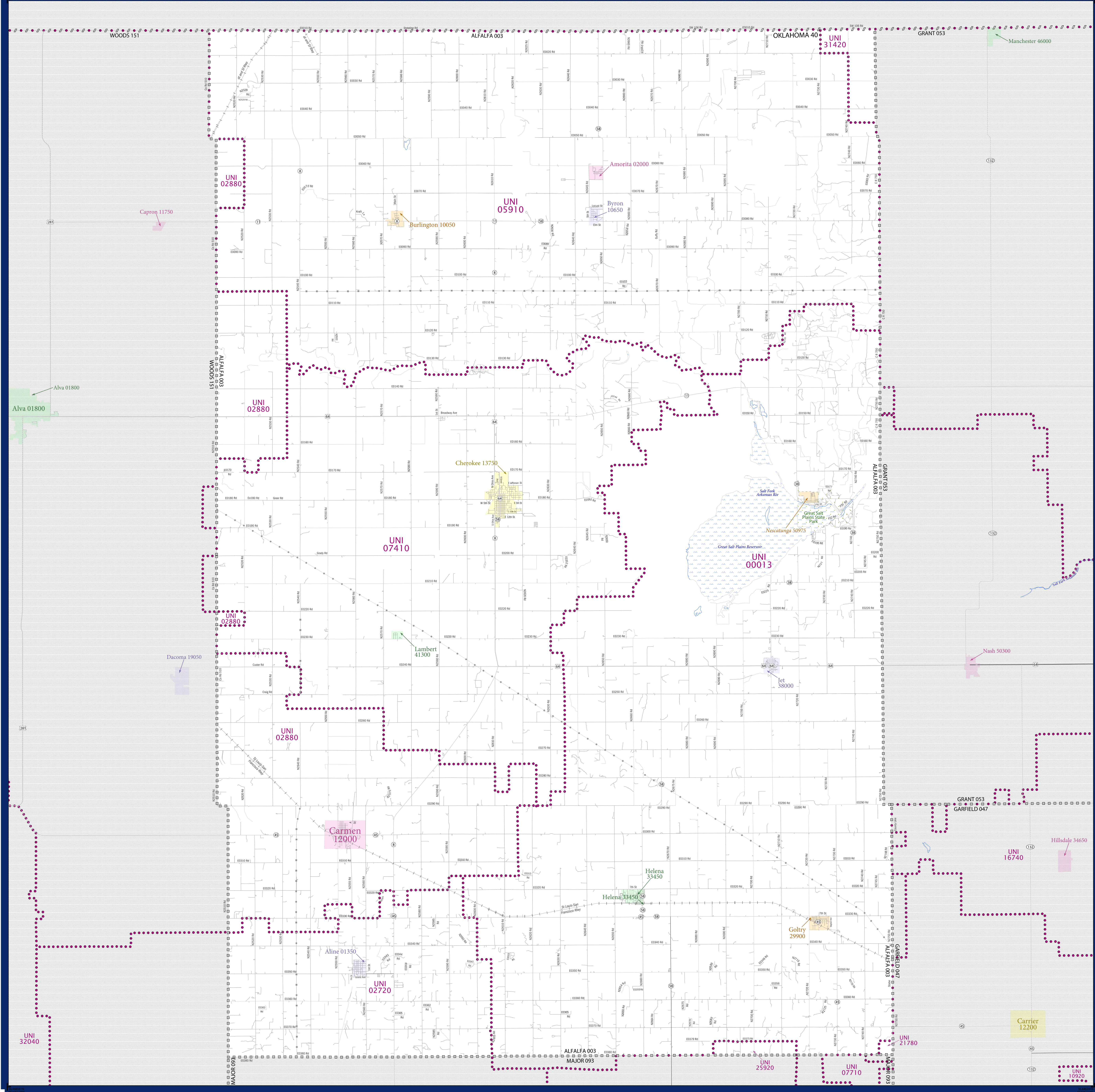


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Alfalfa County, OK

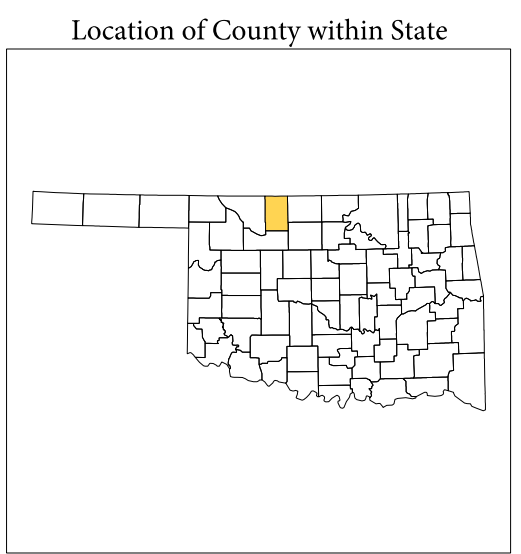
