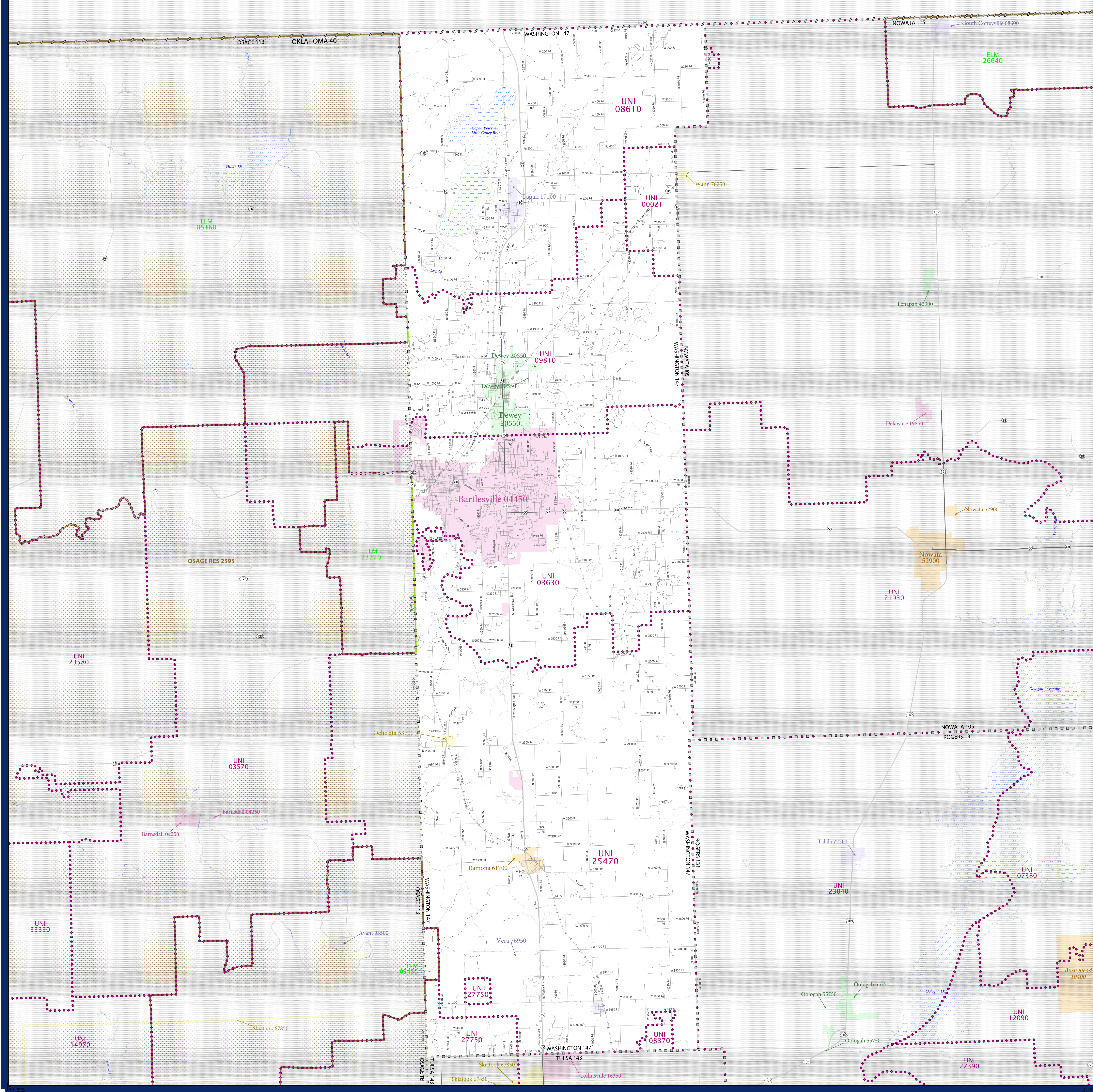


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Washington County, OK

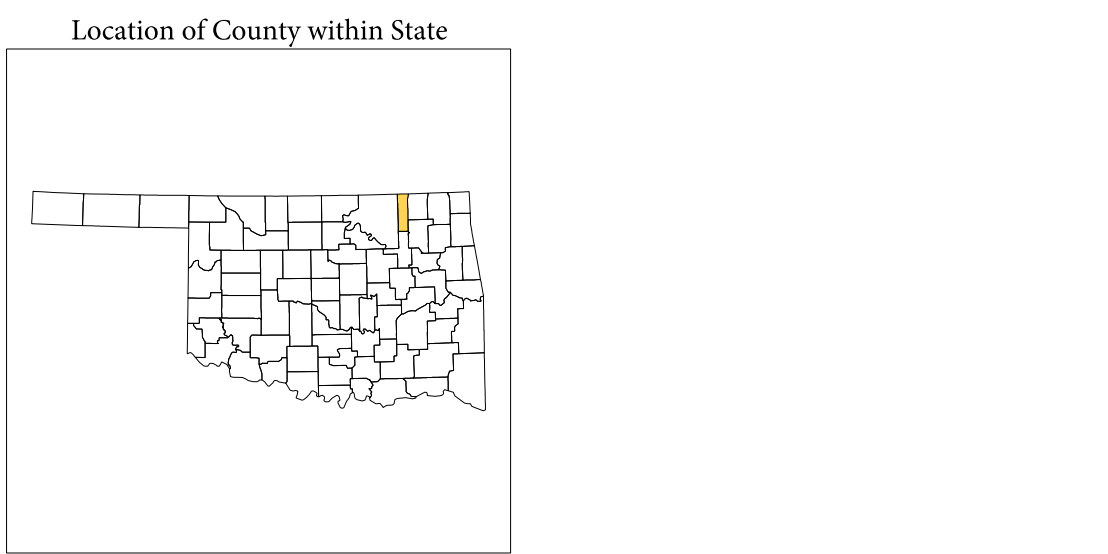
