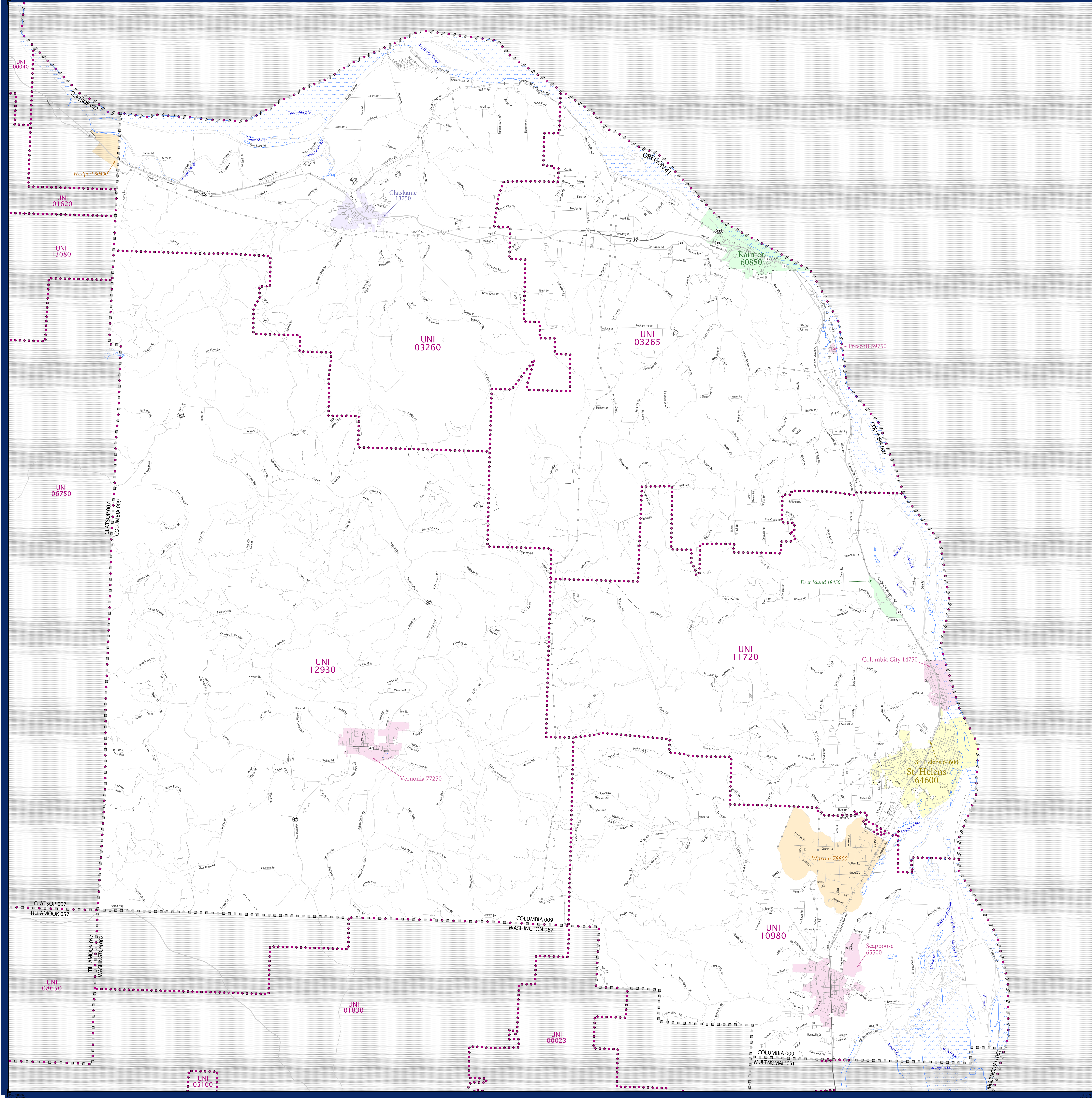


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Columbia County, OR

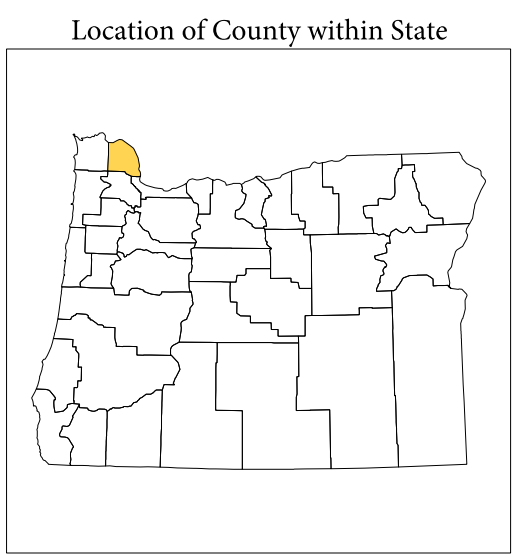
