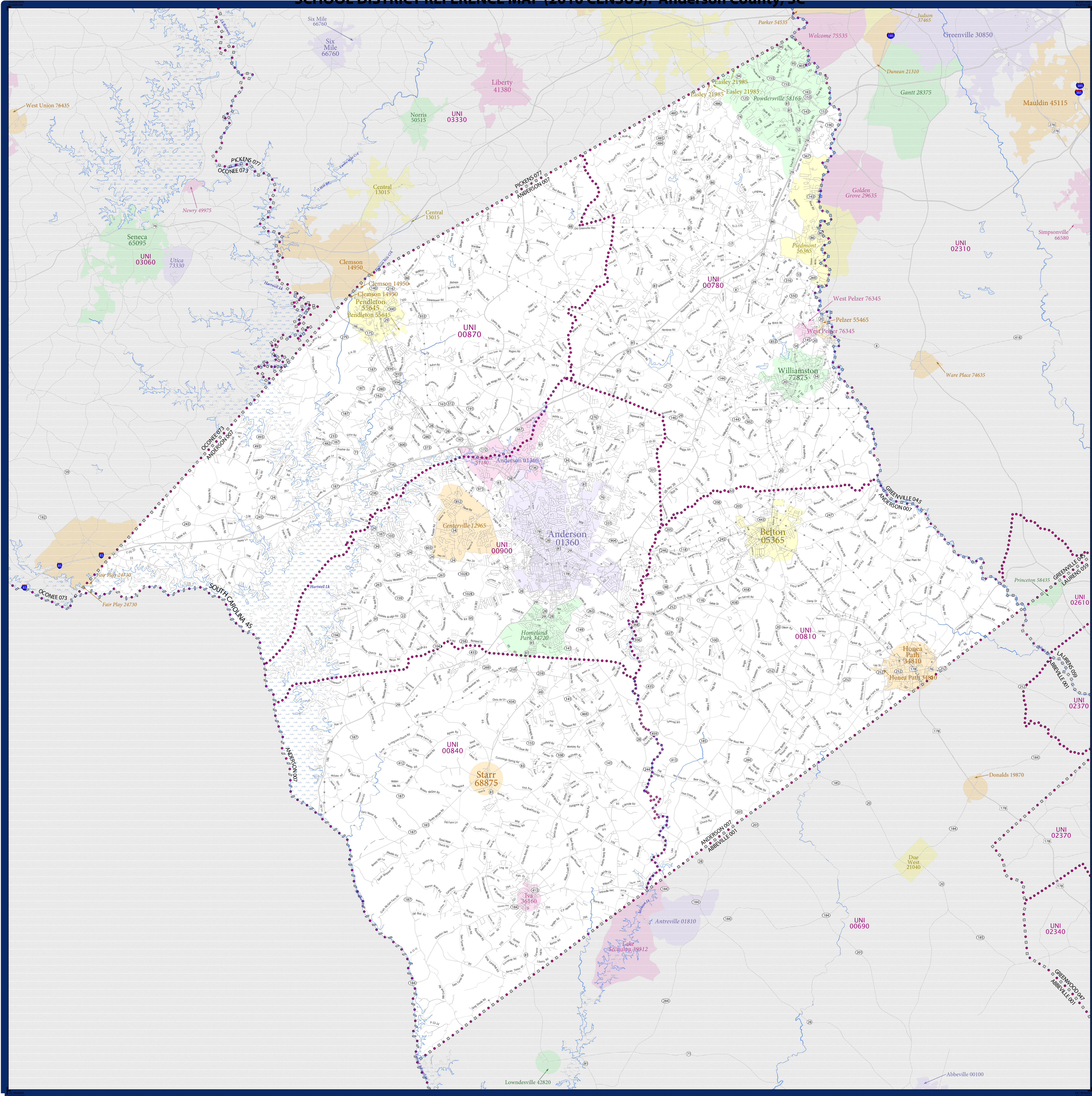


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Anderson County, SC

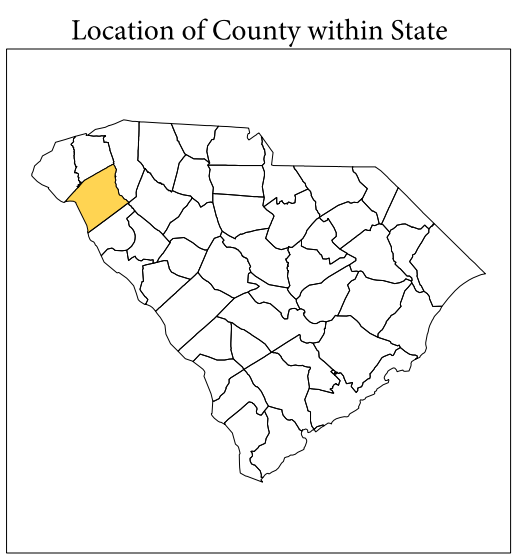
