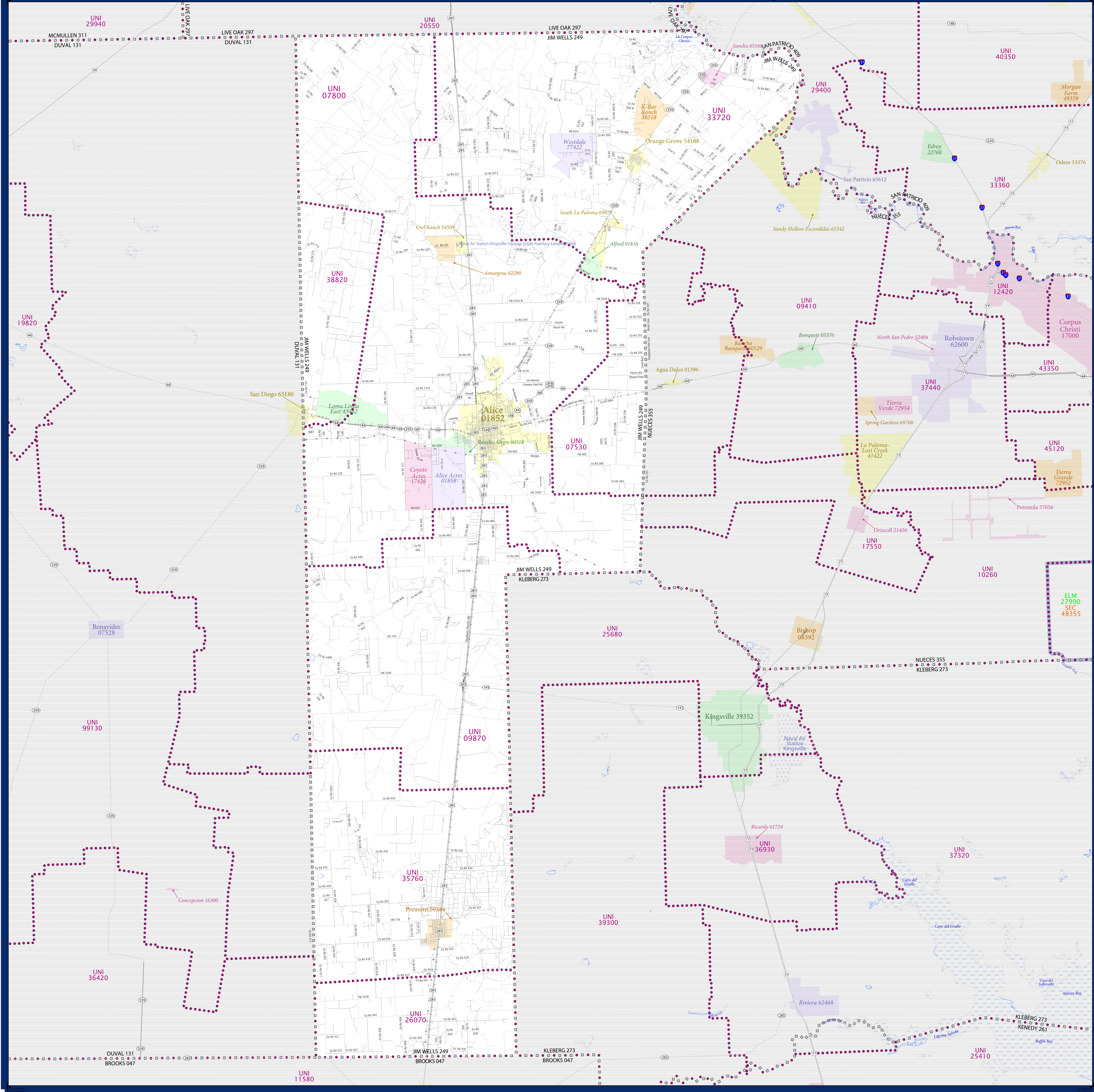


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Jim Wells County, TX

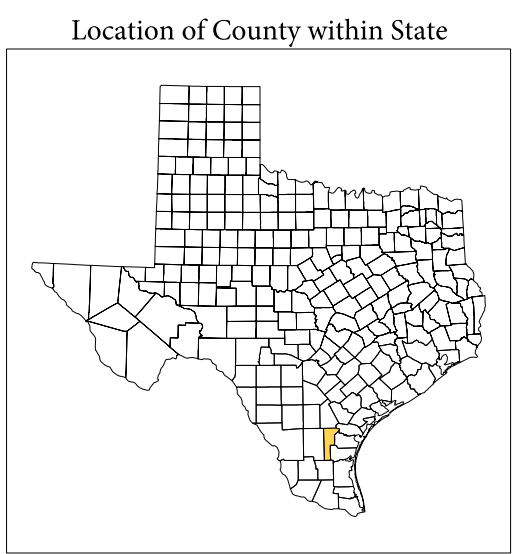
