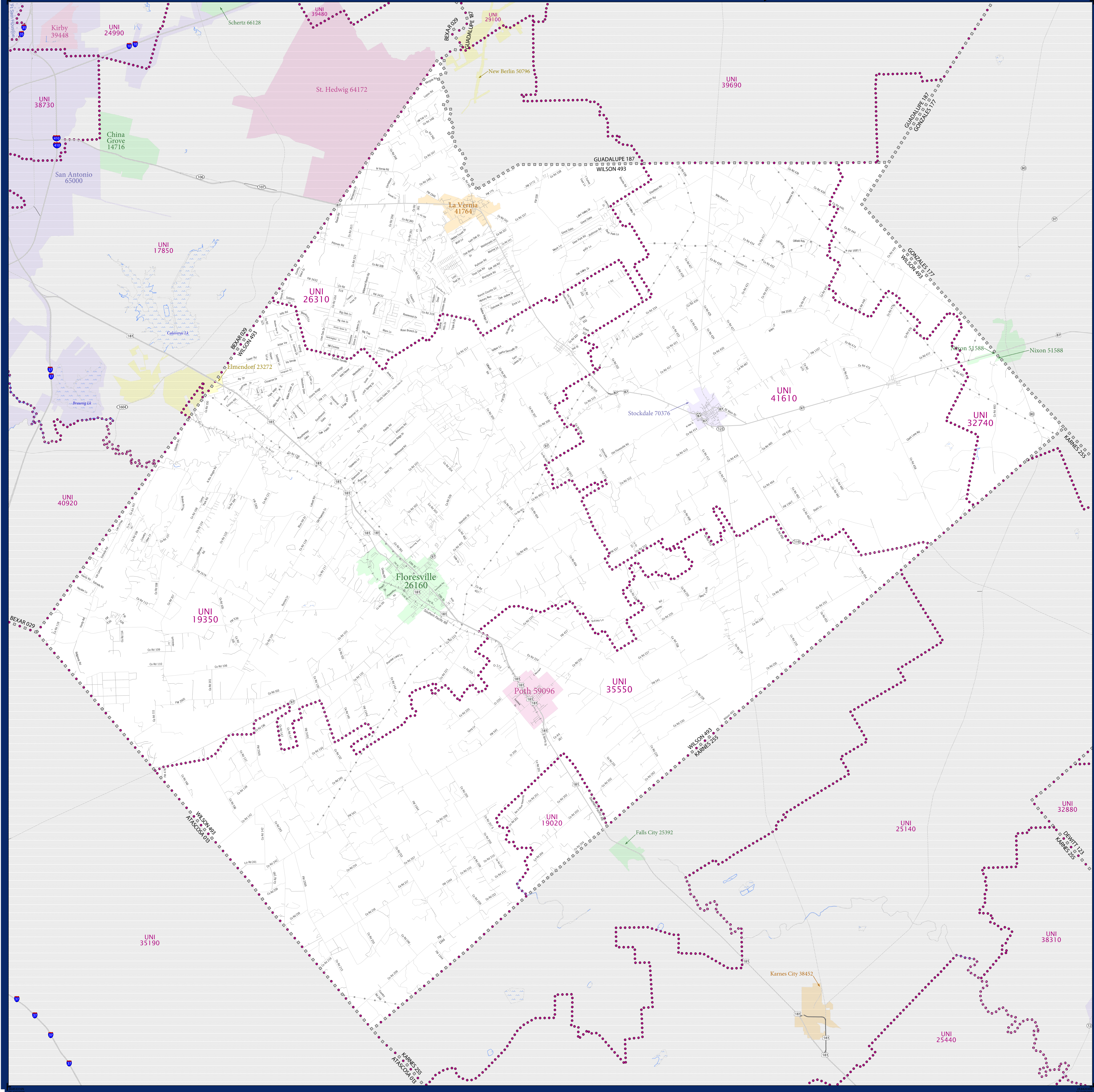


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Wilson County, TX

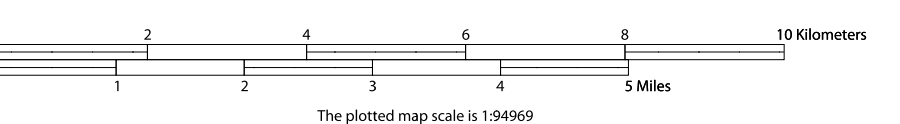
