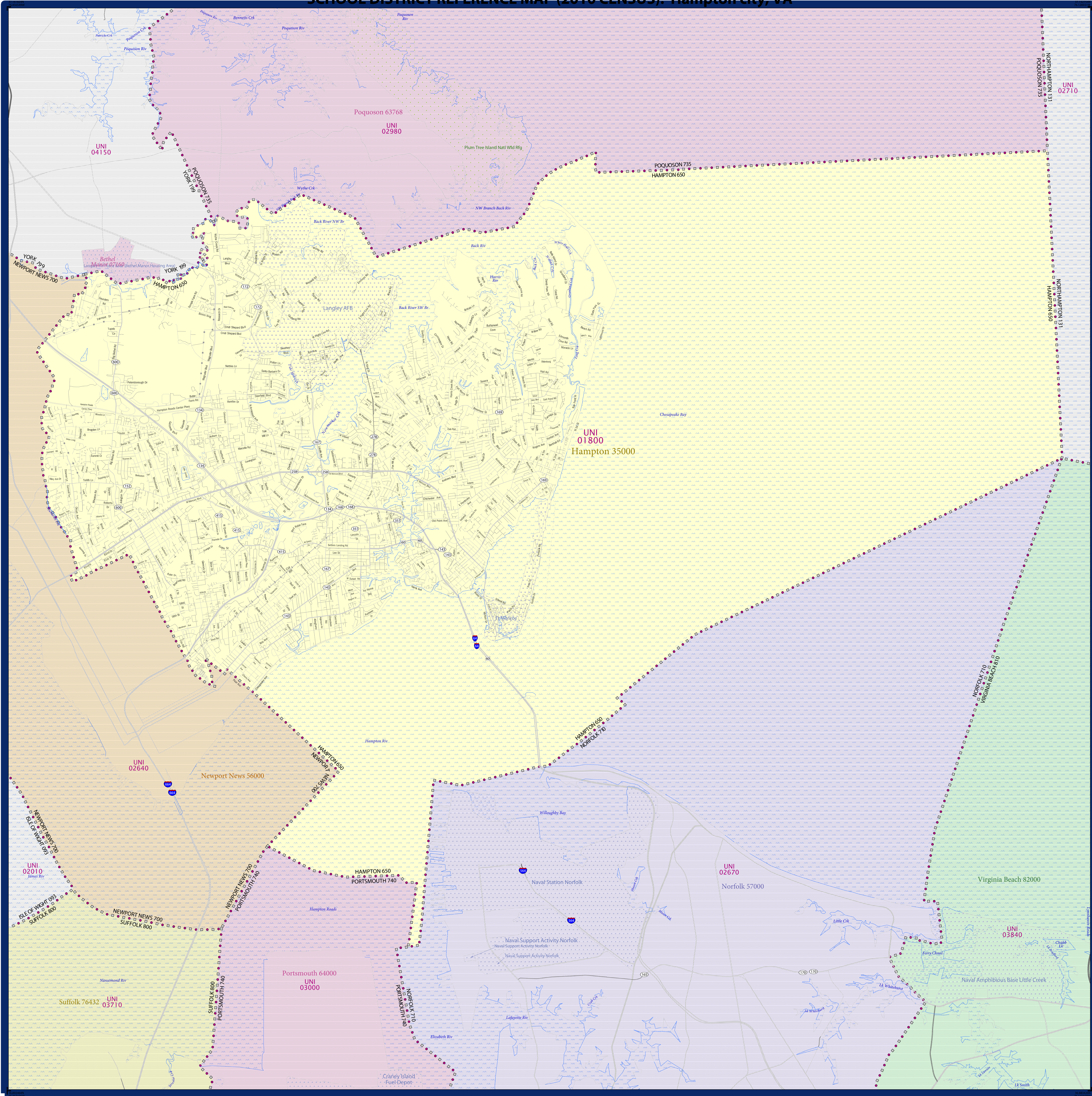


SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Hampton city, VA

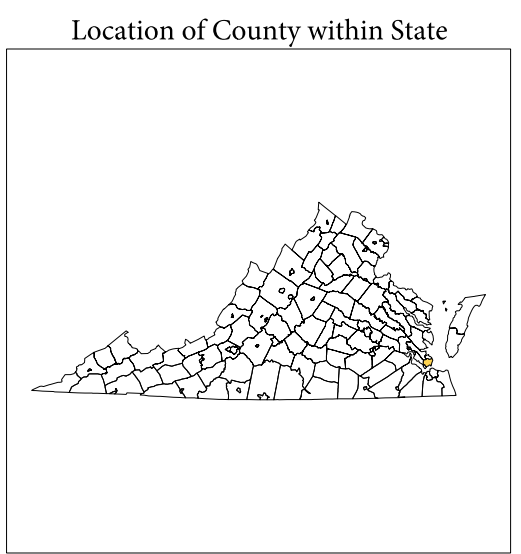
Where state, county, and/or MCD boundaries coincide, the map shows the boundary symbol for only the highest-ranking of these boundaries.
