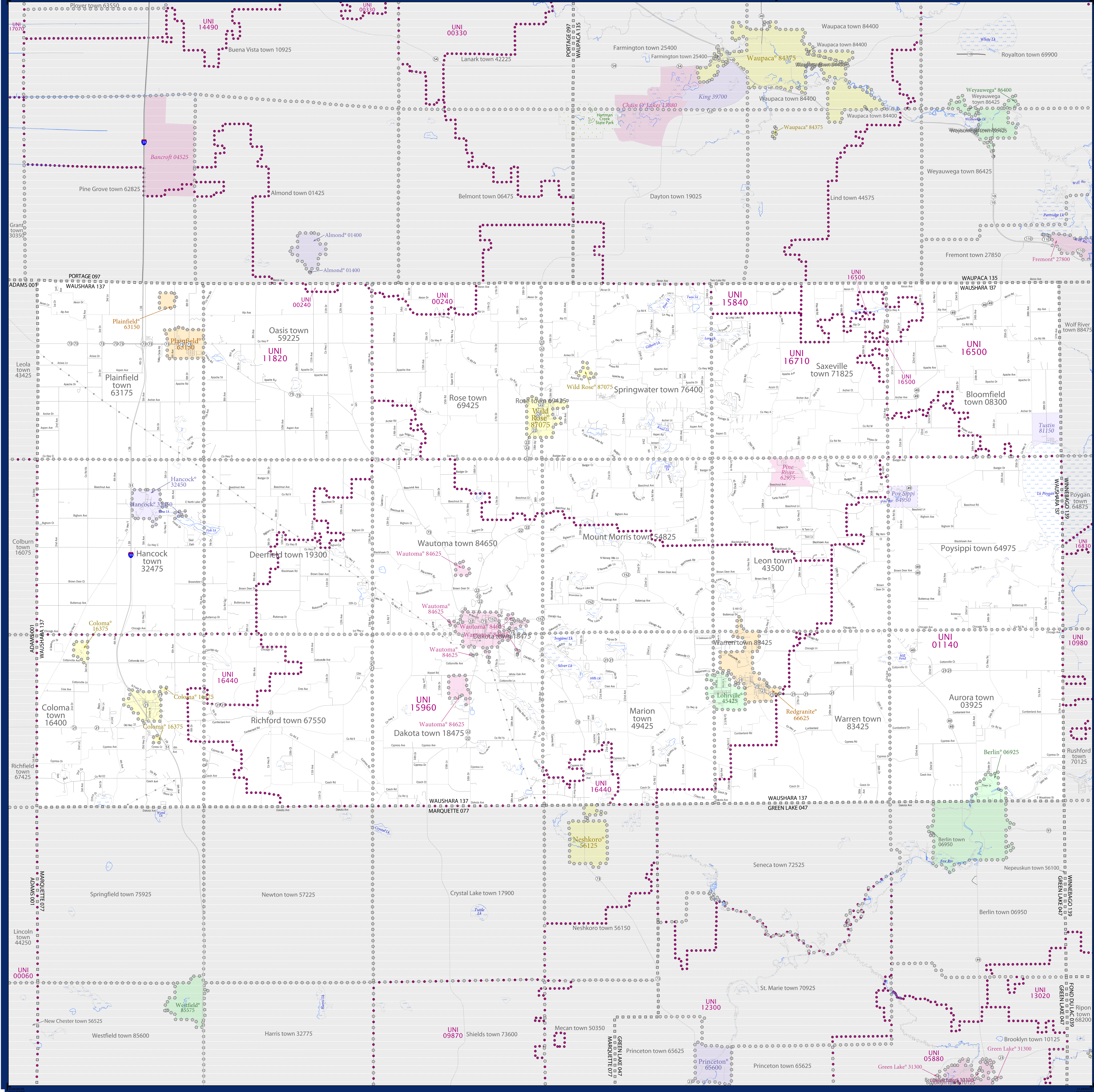


# SCHOOL DISTRICT REFERENCE MAP (2010 CENSUS): Waushara County, WI

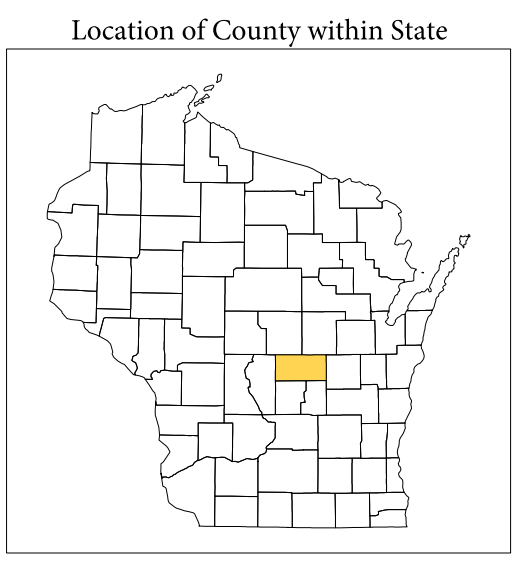

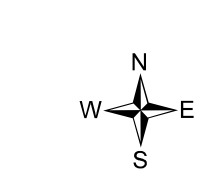
